All use of these images without a license agreement or a written consent from photographer Pasi Aalto is strictly forbidden and will result in an additional fee and/or legal actions.

General terms of use

- 1. Photographer Pasi Aalto is the copyright holder and retains all rights to the images.
- The image should be credited with "Photo: Pasi Aalto / pasiaalto. com" either beside each image or in another way equally visible in accordance to international practice. Incorrect or missing credits are charged with a fee of 100% of the sale price of the actual image or a minimum of USD 200.
- A single copy of the publication is delivered to photographer Pasi Aalto. If publishing online, a link to the actual article or site will be sent by email to pasi@pasiaalto.com.
- When using the images in a video production, the images should be credited in the end credits. Commercials and news reports are exempt.
- Photographer Pasi Aalto is given the right to refer to the client in his own marketing.
- 6. The client kan only use the images as defined under "agreed use", and this contract is only valid for a single publishing without exclusivity. Re-distribution and/or re-sale of the images to a third party is strictly prohibited. All re-use or new/changed use of the images require a new license with photographer Pasi Aalto with changes in terms accordingly. Any use without prior written agreement is subject to an extra fee of 200% of the sale price of the actual image, with a minimum of USD 850.
- 7. The images can not be resold, redistributed or in another way be made accessible to others in digital format, in paper or in any other form. If the client is a marketing agency or is purchasing the license for a third party, they guarantee that only third parties that agree to all of the terms in the contract can use the images and the third party has to be included under the "agreed use" terms of this contract to be valid. The images should not be made available in a matter that enables reuse if publishing online.
- 8. Manipulation of the images is not allowed execpt for minor crops and color adjustments for print processes.
- 9. Photographer Pasi Aalto gives no guarantee of future access to images after they are delivered unless stated otherwise under "special terms."
- 10. If the client is a private norwegian resident, he is given post-purchase withdrawal rights in accordance to norwegian law.
- 11. The purchase is binding. The price given under "price and payment" should be paid by the client within 14 days of receiving the invoice. Failure to pay the invoice renders this license invalid and the clients use of the images is seen as a violation of the copyright of photographer Pasi Aalto.
- 12. The image files can be saved in the clients database for the purpose of making them available to personnel working on the producation. Besides this right no archiving of the image files is allowed.
- 13. - 14. It is forbidden to use the images to promote another photographer or photographic service than photographer Pasi Aalto.
- 15. The client will respect photographer Pasi Aaltos intellectual rights to the material and the rights of the persons in the images to be portrayed in a dignified and just manner. Use of the images in a way that can seem misguiding, hateful, rasist, defamatory, fraudulent, lewd, obscene, vulgar, objectionable or in a manner that can be deemed illegal or pornographic, or in another way that violates photographer Pasi Aaltos or the portrayed persons integrity is strictly prohibited and will not be tolerated.
